# **Additional Information**

The information below indicates additional information that the organisation included in their APCO Annual Report.

Please tell us about any innovative packaging sustainability initiatives you have implemented during your chosen 12 month reporting period.

Our biggest initiative has been to commence our plan to no longer require stretch wrap on our pallets of wine. Instead, we have taken advantage of the cyclic nature of our logistics. When we fill pouches at a winery supplier with our mobile filling line, we send all of our drygoods (packaging materials) in collapsible pallet sized crates and extras that are collapsed. We then pack our full cartons of wine into the crates. These are sent to our main warehouse. When it is time to sell the wine, the crates are sent to our 3PL who sends out single cases via Aust post and then returns the crates to our main warehouse so the cycle can happen again.

Please tell us of any constraints you may have had during your chosen 12 month reporting period that has impacted on your packaging sustainability initiatives and Covenant obligations.

The main constraint we had at the beginning of the period not having a recycling partner for our pouches following the Redcycle demise. Finding Plasmar has solved this problem and our recycling program is back on track.

# **APCO Action Plan Commitments**

Criteria 2:

#### Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).





- Use the Sustainable Packaging Guidelines to review our packaging to identify opportunities for improvement.
- Record the outcomes of reviews or packaging using the Sustainable Packaging Guidelines so that any team member can refer back to them in future and for auditing purposes.
- Conduct packaging reviews using the SPGs for **95**% of our packaging.

## Criteria 3: Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Aim to use recycled materials in any packaging where this is feasible, including:
  - Primary packaging
  - Secondary packaging
  - Tertiary packaging

#### Criteria 4: Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

• Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

Criteria 5: Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

• As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

Criteria 6: On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

• Develop a system to collect and recycle used packaging generated at our facilities.





Criteria 7:

## Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Undertake the following to help reduce the impact of litter:
  - Look for opportunities to redesign packaging to eliminate components that may have the propensity to become litter
  - Strive to make our business paperless.
    increase use of re-useable/collapsible pallet crates in logistics chain to remove need for stretch wrap.
